

Supported Employment

Chrysalis believes that every person with a serious mental illness is capable of working in the community with the right support and work environment.

Vocational Peer Support

Chrysalis Peer specialists use their lived experiences with mental illness and/or substance use to help others achieve their personal and work-related goals.

Supported Employment (SE) Demonstration- NEW PROGRAM!

A 6-year study, supported by the US Social Security Administration, that looks at how employment services, provided along with integrated behavioral health and social services, can help people experiencing mental illness get a job.
